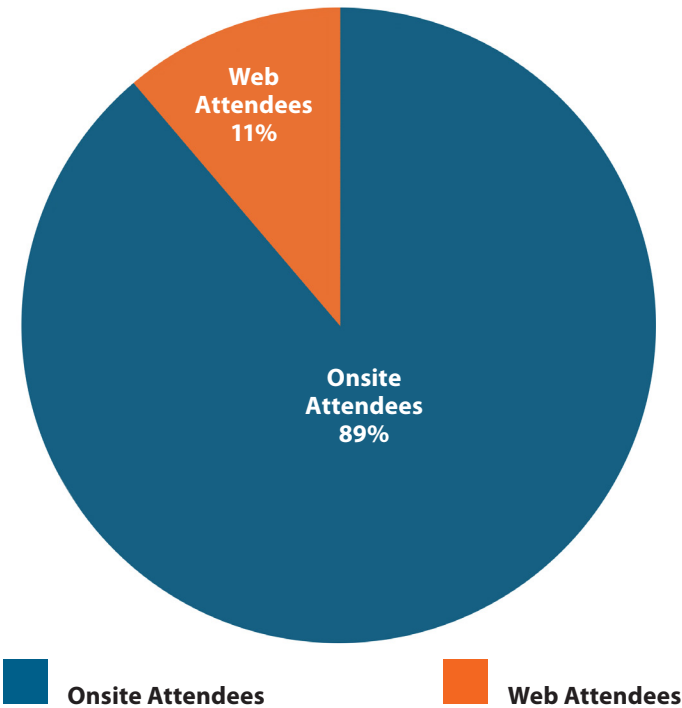

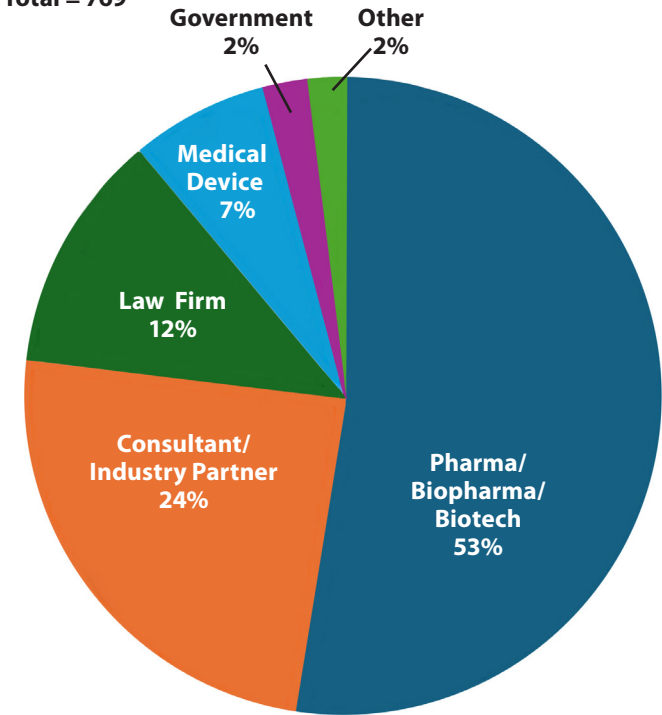
TOTAL REGISTRANTS

Total = 769



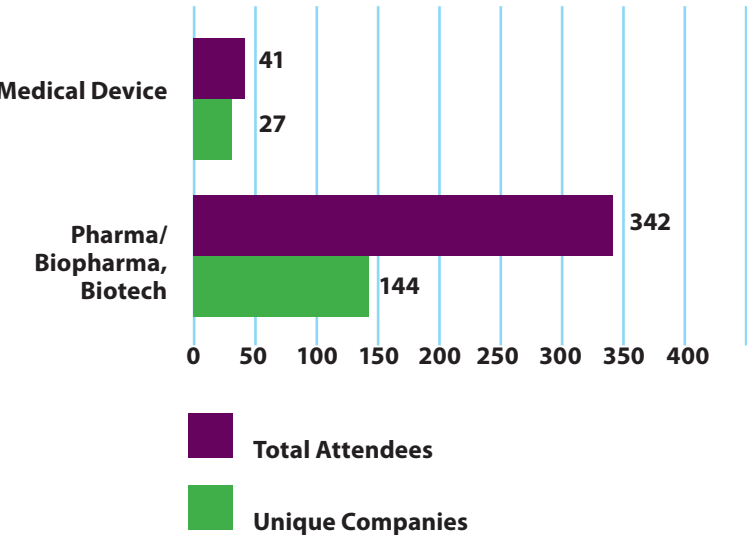
% ATTENDEES BY ORGANIZATION TYPE

Total = 769



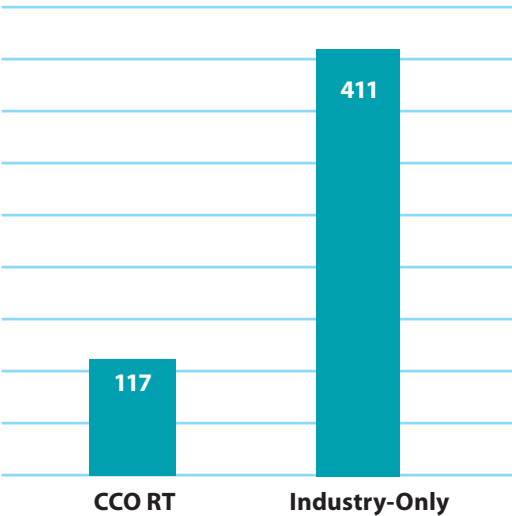
INDUSTRY TYPE
